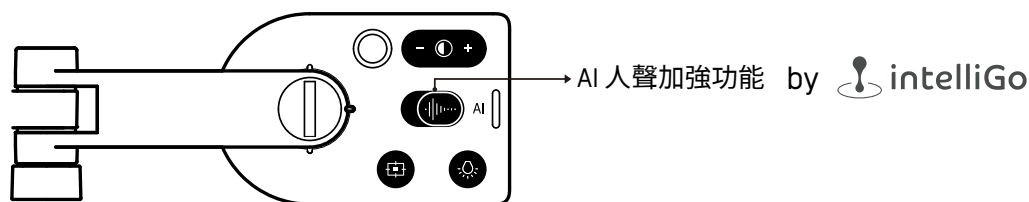

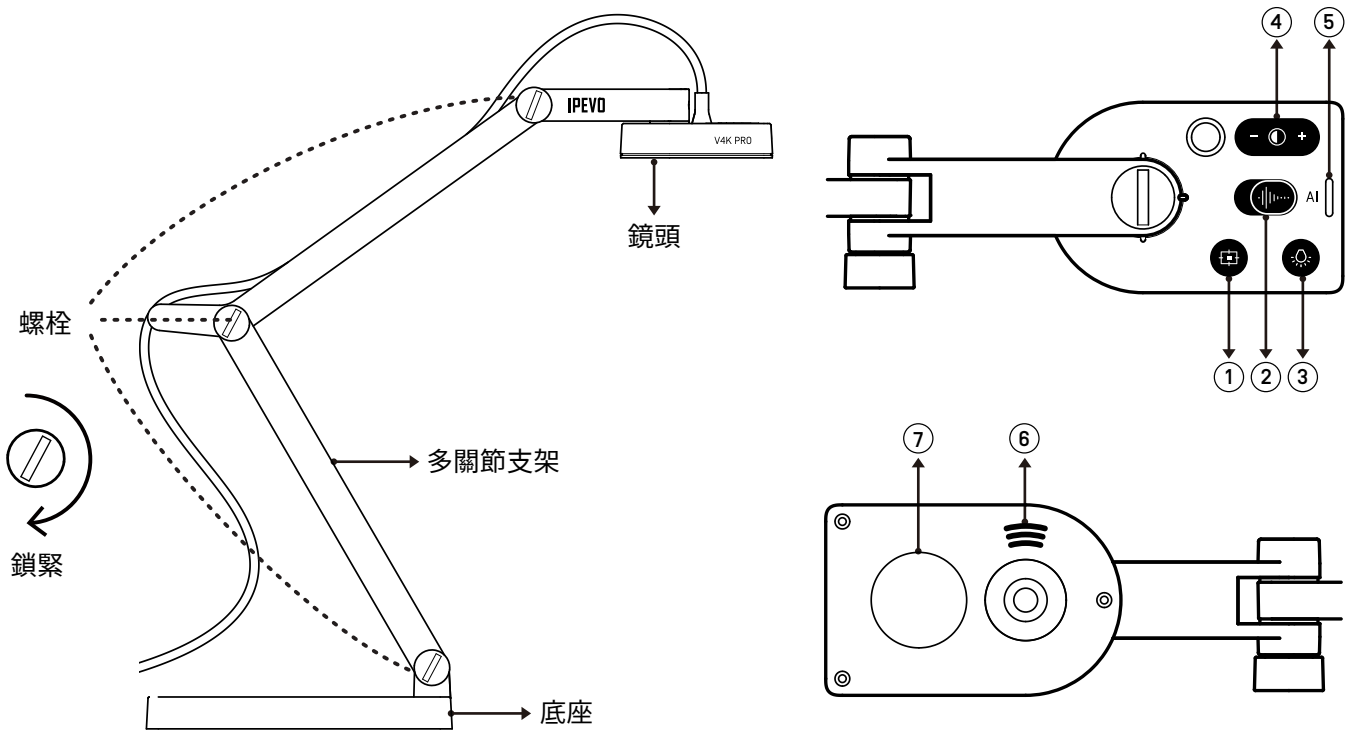

① 對焦按鈕：對焦即時影像或改變對焦模式

- 單按一次為對焦
- 長按按鈕，直到LED指示燈閃爍，變更為單次對焦模式。預設為連續自動對焦模式
- 再按一次則改回連續自動對焦模式

② AI人聲加強功能開/關

- 開關向右滑至AI標記一側，便開啟人聲加強功能

③ LED燈開/關

④ 曝光補償調整：透過曝光補償鈕可手動增加或減少影像的曝光，只要利用+/-的按鈕即可增減影像的明亮度

⑤ LED指示燈：相機使用中顯示白色燈光

⑥ 麥克風：

- V4K PRO 120 使用中開啟，可作為視訊會議或錄影時音訊來源
- 最佳收音距離推薦：30至70公分
